#### 1) Welcome and Introductions

Dawn Petschauer, Chair of the Rio Hondo (RH) Watershed Area Steering Committee (WASC), welcomed Committee Members and called the meeting to order. Los Angeles County Public Works (Public Works) staff conducted a brief tutorial on WebEx and facilitated the roll call of Committee Members. Public Works staff made self-introductions and a quorum was established.

## 2) Approval of Meeting Minutes from August 20, 2024

Public Works staff presented the minutes from the previous meeting. Member Mark Hall motioned to approve the meeting minutes, seconded by Chair Petschauer. The WASC voted to approve the August 20, 2024 meeting minutes with 10 votes in favor, 0 opposed, 1 in abstention (approved, see vote tracking sheet).

## 3) Program Updates

Public Works staff provided an update, noting:

- The Business Relations and Contracts Division released the Watershed Coordinators Request for <u>Statement of Qualifications</u>. The deadline to submit a <u>Statement of Qualifications</u> is on October 31, 2024 at 5:30 pm.
- The Fiscal Year (FY) 2023-24 Quarterly Report covering April to June was due on August 15. The
  FY 2023-24 Annual Report, covering July 2023 to June 2024, is due December 31. The Mid-Year
  Report, covering July to December, previously known as Quarter 1 (Q1) and Quarter 2 (Q2) Reports
  will be due on February 15, 2025.
- The Municipal Program Reporting Module has been updated to streamline the renewal process for the Municipal Transfer Agreements. SCW Program Payments are generally available for disbursement by December 31, based on the timing of revenues collected by the Program.
- The Municipal Program will be transferred to another team within Public Works in the coming months.
- The Public Education and Community Engagement Grants Program formally launched on September 24. The Public and Education and Community Engagement Grants Program, in collaboration with the Water Foundation, will support education and community engagement efforts related to stormwater and urban runoff capture. Proposals will be accepted until May 31, 2025 and will be evaluated and awarded on a rolling basis. More information can be found on the <u>Water</u> <u>Foundation website</u>.

Member Bryan Matsumoto confirmed with Public Works staff that the vacant Community Stakeholder seats on the WASC are appointed by the Los Angeles County Board of Supervisors (Board). Public Works staff noted that Member Matsumoto will be the primary Committee Member representing Nature for All due to recent seat vacancies.

#### 4) Watershed Coordinator Updates

Watershed Coordinator Julie Millet presented on recent and upcoming activities and provided an overview of Watershed Coordinator tasks. Presentation slides can be found on the <u>SCW Program website</u>. Highlights include participating in the Watershed Coordinators' Tribal Allyship Working Group and attending Active San Gabriel Valley's Noche de las Luminarias event. Watershed Coordinator Millet also noted that funds through the Public Education and Community Engagement Grants Program must be spent no later than July 2026.

Upon inquiry, Chair Petschauer clarified that the three Load Reduction Strategy (LRS) projects mentioned in the presentation are in Eaton Wash, Rubio Wash, and Alhambra Wash, all of which were identified as downstream solutions to meet compliance requirements. Chair Petschauer noted that while the design has been delayed, the LRS projects are considering ultraviolet treatments instead of sanitary sewer diversions. Watershed Coordinator Millet noted that although three projects are being designed, only the most promising project will move forward. Chair Petschauer informed the WASC that despite the LRS projects achieving Water Quality Benefits, the City of Pasadena decided against proceeding with construction after determining that the benefits did not justify the costs; other cities involved with the LRS projects will be moving forward with the most promising LRS project.

Upon inquiry, Public Work staff confirmed that the current Watershed Coordinator contract will continue through the end of calendar year 2025, with a new contract beginning in January 2026. Public Works staff also explained that Watershed Coordinator contracts need to be reviewed on a yearly basis due to annual budget allocation.

Chair Petschauer shared that the City of Pasadena is conducting a community outreach event on October 19 at the Victory Park Farmers Market to solicit feedback on the Sierra Madre Median Enhancement and Master Plan Project. The project intends to enhance medians along the 1.25 miles of Sierra Madre Boulevard and involves the addition of 800 new trees and 60,000 square feet of vegetation. Chair Petschauer mentioned that the project was a SCW Program Technical Resources Program (TRP) project,

the Sierra Madre Boulevard Green Street Stormwater Capture Project, and noted that design is being funded by the City of Pasadena. Upon inquiry, Chair Petschauer confirmed that the project does not plan to interfere with the Tournament of Roses float parking area. Chair Petschauer also expressed interest in collaborating with Active San Gabriel Valley and highlighted the organization's efforts to add bikeways near the Sierra Madre corridor, along Eaton Wash. Member Brent Maue referenced Huntington Drive as an example of medians that have been enhanced and modified to take water from the street.

## 6) Presentations and Discussion Items

- a) Watershed Planning Recap
  - i) Watershed Planning Recap Phase 1

Public Work's SCW Program Watershed Planning (Watershed Planning) staff within Public Works presented on the Watershed Planning progress, including an update on the Initial Plan Framework and the Community Strengths and Needs Assessment (CSNA). Mike Antos (Stantec) also provided an overview of the outcomes from the Phase 1 Watershed Area Steering Committee (WASC) Watershed Planning engagement workshops held during previous WASC meetings for all nine SCW Watershed Areas, which included a Program-wide and Watershed Area specific synthesis of the feedback received during the workshops. Presentation slides can be found on the SCW Program website.

Watershed Coordinator Richard Watson shared that it would be beneficial to understand the level of development permitted in the Los Angeles County Flood Control District's right-of-way, referencing the Eaton Wash Dry-Weather Diversion Project. Watson also emphasized the importance of considering the interrelationships among the six different Rio Hondo Watershed Area washes to better coordinate projects.

Member Tom Love agreed with the synthesis presented and highlighted the value of understanding how projects are distributed throughout the County. Member Love also mentioned that the number of acres of open space per population could be a metric that is considered when defining disadvantaged communities. Antos noted that the Initial Watershed Plans will integrate data from the Los Angeles County Park Needs Assessment Plus, which discusses park accessibility across the region.

Chair Petschauer mentioned that while existing parks are ideal locations for projects, there is also an interest in developing undeveloped, city-owned properties into green space. Antos inquired if cities have publicly accessible datasets listing undeveloped, city-owned properties, as such data would be beneficial to add to the Watershed Planning database.

Chair Petschauer recommended that Water Quality Benefits be quantified during post-construction. Chair Petschauer also highlighted the importance of understanding the priorities of communities located in Unincorporated Los Angeles County. Upon inquiry, Chair Petschauer noted that the accumulation of different programs, such as trash compliance, community education, and street sweeping, has contributed to improved water quality.

Member Jill Fosselman cautioned about an overconcentration of projects in certain areas and expressed interest in discussing methods to ensure balanced project distribution through the Watershed Planning effort.

Upon inquiry, Antos confirmed that the San Gabriel Valley Greenway Network Strategic Implementation Plan is being evaluated during the Watershed Planning process.

## ii) What We Are Doing Next

Watershed Planning staff provided an overview of the Initial Watershed Plan Framework.

Chair Petschauer recommended that constructed project's water quality data, not just modeled data, be included in the Watershed Planning analysis to ensure that water quality effects can be accurately quantified. Chair Petschauer referenced the preSIP: A Platform for Watershed Science and Project Collaboration SCW Program Scientific Study, as an example analysis that utilized existing project data. Antos noted that the setting of Water Quality targets is still being evaluated.

Watershed Planning staff shared about the Watershed Planning methodology and process being conducted to develop the Initial Watershed Plans and accompanying online planning tool. Upon inquiry, Public Works staff confirmed that the planning tool will be publicly available. Member Fosselman inquired if the planning tool can be used to filter out projects that do not meet community needs. Watershed Planning staff explained that planning tool and Stormwater Investment Plan (SIP) Tool may be used collectively as resources to assist WASCs in make informed decisions when considering funding projects.

Watershed Planning staff also confirmed that potential Scoring Criteria revisions may be implemented, however, they are not directly associated with the Watershed Planning effort. Watershed Planning staff added that project applicants will eventually be required to include an explanation in their applications describing how proposed projects align with a WASC's priorities and targets specified in the Watershed Area's Initial Watershed Plan, once available.

Watershed Planning staff stated that the Watershed Planning process is adaptive, and the Initial Watershed Plan is scheduled to be completed by June 2025. Upon inquiry, Watershed Planning staff explained that there will be another engagement session with WASCs to review the Initial Watershed Plan before June 2025. Watershed Planning staff shared that focused engagement with specific interested parties has also been conducted.

Antos provided an overview of the proposed CSNA survey and explained that once it is launched and LA County communities begin taking the survey to identify their needs and priorities, the results will be displayed in an online dashboard and will be included in the <a href="Spatial Data Library">Spatial Data Library</a> (SDL). Member Love expressed support for the CSNA and noted how the findings can guide funding decisions and be used as a resource for the WASC during project prioritization discussions. Hayat Rasul (Stantec) added that data from previous surveys administered by the Watershed Coordinators will also be incorporated into the CSNA dashboard. Chair Petschauer voiced the value of tracking survey data over time and continued coordination with municipalities to better understand their efforts.

Upon questioning, Antos shared that the survey data is not meant to be weighted based on whether a response is from an individual or an organization. Antos added that the Public Education and Community Engagement Grants Program can be used by organizations towards community engagement, including survey distribution, that can contribute to the CSNA.
