1) Welcome and Introductions

Madeline Chen, Co-Chair of the Lower Los Angeles River (LLAR) Watershed Area Steering Committee (WASC), welcomed all Committee Members and called the meeting to order. Los Angeles County Public Works (Public Works) staff facilitated a roll call, conducted a brief tutorial on WebEx, and provided an overview of meeting guidelines and participation instructions for any participants joining online. A quorum was established.

2) Approval of Meeting Minutes from January 28, 2025

Public Works staff presented the minutes from the previous meeting. Member Pamela Torres motioned to approve the minutes, seconded by Member Gladis Deras. The Committee voted to approve the January 22, 2025 meeting minutes with 10 votes in favor, 0 opposed, 4 in abstention, and 2 absent at the time of vote (approved, see vote tracking sheet).

Public Works staff informed the WASC that the motion noted the incorrect meeting date and advised the WASC to revise the motion. Member Adriana Figueroa motioned to amend the meeting minutes motion to the correct date of January 28, 2025, and Co-Chair Chen seconded the motion. The Committee voted to approve the January 28, 2025 meeting minutes, with the date corrected, with 11 votes in favor, 0 opposed, 4 in abstention, and 1 absent at the time of vote (approved, see vote tracking sheet).

3) Committee Member and Program Updates

Public Works staff provided an update, noting:

- Mid-Year Report (covering July-Dec 2024, previously known as the Quarter 1 (Q1) & Q2 Reports)
 was launched on January 17 and is due on February 15, 2025. The deadline for submittals has
 been extended to February 28.
- The new Metrics & Measures section is now available as a new tile in the Reporting Module for Project Developers approved in Fiscal Year 2020 – 2020 (FY20-21) through FY23-24 Stormwater Investment Plans (SIPs) to fill out by February 28th. Project Developers received an email with instructions and a link to the Regional Program Performance Measures Guidelines.
- The 2025 Quarter 3 Quarterly Funding Report & Matrix is available on the <u>SCW Program website</u>. In support of Public Works, the Regional Coordination team prepares quarterly funding reports that include a high-level overview of recent funding policy highlights and a funding matrix that shares currently active and upcoming funding opportunities that may be relevant to SCW Program projects. The Regional Coordination team is monitoring ongoing activity related to Federal funding opportunities.
- FY24-25 Transfer Agreements/Addendum distribution began in December. An email blast was sent out to new and continuing project developers with instructions on how to use the Transfer Agreement functionality within the Reporting Module. Project developers are advised to start uploading their supporting documents, such as the Scope of Work, Authorization, and California Environmental Quality Act documents as applicable to execute their agreements. - The upcoming Regional Oversight Committee (ROC) meeting is scheduled for March 12 at 1:00pm, where the ROC will begin its first Biennial Report Session of the series. The meeting will gather public input, and public comment will be extended from 2 to 5 minutes. To view meeting details please visit the ROC events webpage.
- The LA County Flood Control District is partnering with the Water Foundation to administer the Safe, Clean Water Public Education and Community Engagement Grants Program. The program will support education and community engagement efforts related to stormwater and urban runoff capture within the LA County Flood Control District. The deadline to submit a grant proposal to be evaluated during Round 3 is April 4, 2025. After the Round 3 deadline, proposals will be evaluated and awarded on a first-come-first-serve basis until May 31, 2025, as long as funds are still available. - Public Works' Watershed Planning staff noted that a methodology has been prepared to develop Initial Watershed Plans for each Watershed Area and is starting with the Lower Los Angeles River Watershed Area to ensure quality control and consistency across all nine Watershed Areas. Watershed Planning staff shared that based on baseline findings and benefit forecasts, strategies to achieve SCW Program goals are also being developed.
- The Watershed Planning Framework is available on the SCW Program website under the Adaptive Management tab. The Community Strengths and Needs Assessment (CSNA) Survey and a Frequently Asked Questions document have also been launched and are available on the <u>SCW Program website</u>. The Watershed Planning Tool, including a GIS map and dashboard, will also be launched to identify opportunity areas. 4) Watershed Coordinator Updates

Watershed Coordinator Tara Dales shared an update about activities in LLAR Watershed Area over the past month. Highlights included connecting with new interested parties in the area that could benefit from conducting Scientific Studies, and sharing recent work that the Watershed Coordinators across the nine Watershed Areas are conducting to track green schoolyards across the Program Area. 5) Presentation and Discussion Items

a. Ex Parte Communication Disclosure

There were no ex parte communications.

b. Project Modification Requests (PMRs) Overview for WASC (Presentation by Stantec)

Emily Ng (Stantec, Regional Coordination) provided an overview of PMRs submitted in Round 6 for the LLAR WASC. Ng shared that the LLAR WASC received two PMRs. Public Works staff shared that one project, the Long Beach Municipal Urban Stormwater Treatment – Phase 1, was deemed inconsistent with the LLAR SIP. Public Works staff noted that the other project, Gateway Water Management Authority Gateway Area Pathfinding Analysis (GAP Analysis Phase 2), did not need to submit a PMR.

c. Project Modification Request (PMR) for WASC Discussion

Long Beach Municipal Urban Stormwater Treatment (LB-MUST) - Phase 1

Member Figueroa confirmed with Colin Averill (City of Long Beach, Project Developer) that the PMR is requesting five increments of \$1 million, and confirmed that each million is intended to be dedicated to Operations and Maintenance (O&M). Averill added that the project's existing municipal leveraged funding only guarantees one year of funding support for O&M. Public Works staff shared that the first three years of funding for LB-MUST totaled to approximately \$10.8 million, and the second phase totaled to \$10.38 million of SCW Program funding, a combined total of around \$21 million dollars. Public Works staff added that typically, a project that requests additional O&M funding must reapply through the Infrastructure Program (IP) during the Call for Projects stage, however, since IP applications were deferred for FY25-26 Call for Projects, Public Works is temporary allowing Project Developers to request up to one year of O&M funds through the PMR Form. Averill confirmed that the City will work to submit a new IP Project Application for O&M funding beyond FY25-26.

Member Dan Mueller asked about external costs that may increase overall project costs, and Averill shared that some work cannot be done in-house, so external contractors are sometimes necessary. Averill shared that the City is actively searching for leverage funds opportunities in the region that support Low Impact Development and O&M opportunities.

Member Dylan Porter asked about the potential impacts of LB-MUST Phase II in the event that the WASC does not fund the PMR request and Averill confirmed that LB-MUST Phase II will proceed with Design however, the project may experience limited operational capabilities post-construction due to restrictions imposed by the current budget.

Member Figueroa confirmed with Public Works staff that LB-MUST can use Municipal Program funding to cover a portion of their O&M. Public Works staff also noted that SIP deliberations will begin at the next LLAR WASC meeting. Averill shared that the LB-MUST Wetland is open to the public and encouraged the WASC to visit. d. Scientific Study (SS) Peer Review

Chair Chen provided a brief overview of the Scientific Scientific Study Peer Review process and introduced Chris Tull to address questions from the WASC.

i. Data-Driven Resource Optimization and Planning System (DROPS)

The DROPS SS Peer Review Summary can be found on the <u>SCW Program website</u>. Watershed Coordinator Dales asked about the source of the data in the DROPS SS. Chris Tull (California Data Collaborative, Project Developer) shared that the data sources may be contributed by federal agencies, interested parties, stakeholders, and other sources.

Member Alysha Chan asked if there are any existing similar studies or tools and how the DROPS Tool would differ. Tull shared that existing tools have different audiences and that the DROPS Tool is primarily intended to be used water agency staff. Tule added that the co-benefits of SCW Program projects will be added as a layer in the DROPS Tool.

Co-Chair Chen referred to a Peer Review comment that asked about extending the project timeline by two years. Tule clarified that the Project Team is still planning for a one-year timeline. Public Works staff shared that the project could submit a PMR for an extension of the project timeline upon a year of completion or the WASC may choose to extend the requested funds over multiple fiscal years in this Stormwater Investment Plan

.

ii. Maximizing Impact of Minimum Control Measures (MCM)

The MCM SS Peer Review Summary can be found on the <u>SCW Program website</u>. Brianna Datti (Craftwater Engineering, Project Developer) shared that the data used for the SS is being calibrated alongside the development of SCW Program monitoring tools. Datti also added that the benefits from MCM implementation, such as pollutant load reduction, will be tracked via a management dashboard. Upon inquiry, Datti clarified that water quality monitoring is not a part of this SS; the SS is a modelling exercise to create a tool to refine such monitoring programs.
