Appendix J. Opportunity Maps

Projects and Programs that deliver multiple benefits are a cornerstone of the Safe, Clean Water (SCW) Program. While individual strategies can support specific SCW Program Goals, they are most effective when implemented together to create synergies across SCW Planning Themes. This appendix illustrates outcomes from the two composite opportunity analyses listed and described below¹:

- Section J.1: Multiple Benefit Opportunity Across Planning Themes- This
 analysis highlighted areas within the Watershed Area (WA) with the highest
 potential to deliver multiple benefits across key SCW Program Planning
 Themes.
- Section J.2: Opportunity to Improve Water Quality and Increase Water Supply- This analysis highlighted areas within the WA with the highest potential to deliver dual benefits—specifically, to Improve Water Quality through pollutant load reduction and Increase Water Supply through stormwater capture.

The maps included in this appendix provide a static representation of the data that aligns with the progress of the Initial Watershed Plans at the time they were developed. For interactive versions of these maps with the most current information, users should use the SCW Program Watershed Planning Tool (Planning Tool). The Planning Tool is regularly updated to incorporate new data, recent investments, and changing watershed conditions; it serves as the preferred method for viewing and analyzing composite benefit opportunity areas².

Figure J-1 and Figure J-2 illustrate the outcomes of the analyses described in Section J.1 and J.2, respectively, as visible on the Planning Tool. As illustrated in the figures, users can zoom in to areas of interest, toggle layers on the legend on the right-hand side of the map, then view details of specific features on the toolbar on the left-hand side of the map.




Figure J-1. Screenshot of the multi benefit opportunity across Planning Themes on the SCW Program Watershed Planning Tool




Figure J-2. Screenshot of the opportunity to Improve Water Quality and Increase Water Supply on the SCW Program Watershed Planning Tool

J.1Multiple Benefit Opportunity Across Planning Themes

Outcomes from this composite opportunity analysis identified areas within the WA with the highest potential to deliver multiple benefits across key SCW Program Planning Themes (Improve Public Health, Increase Drought Preparedness through Groundwater Recharge, Restore Habitat, and Equitably Distribute Benefits to Disadvantaged Communities). Note, the relative opportunity classification (high, higher, highest) used in each map is defined in Appendix I.6.

To support various Program and Project proponent perspectives, analysis outcomes have been exported to several map sets across multiple scales:

- To highlight areas within the WA with the highest potential to deliver multiple benefits across key Planning Themes, a two-square-mile planning grid was developed. Each grid cell overlapping the WA was exported and is shown in the first section below from highest rank (i.e., highest relative opportunity) to rank.
- To support targeted implementation by Municipalities, the opportunity to
 deliver multiple benefits across key Planning Themes was exported at the
 municipal scale to highlight the opportunity levels within each. Each municipality
 overlapping the WA is shown the second section below.
- To support targeted implementation from the perspective of Supervisorial
 Districts, the opportunity to deliver multiple benefits across key Planning
 Themes was exported at the supervisor district scale to highlight the opportunity
 levels within each. Each Supervisor District overlapping the WA is shown in the
 third section below.




Figure J-3. Rank 1 Multiple Benefit Opportunity Across Planning Themes




Figure J-4. Rank 2 Multiple Benefit Opportunity Across Planning Themes




Figure J-5. Rank 3 Multiple Benefit Opportunity Across Planning Themes




Figure J-6. Rank 4 Multiple Benefit Opportunity Across Planning Themes




Figure J-7. Rank 5 Multiple Benefit Opportunity Across Planning Themes




Figure J-8. Rank 6 Multiple Benefit Opportunity Across Planning Themes




Figure J-9. Rank 7 Multiple Benefit Opportunity Across Planning Themes




Figure J-10. Rank 8 Multiple Benefit Opportunity Across Planning Themes




Figure J-11. Rank 9 Multiple Benefit Opportunity Across Planning Themes




Figure J-12. Rank 10 Multiple Benefit Opportunity Across Planning Themes




Figure J-13. Rank 11 Multiple Benefit Opportunity Across Planning Themes




Figure J-14. Rank 12 Multiple Benefit Opportunity Across Planning Themes




Figure J-15. Rank 13 Multiple Benefit Opportunity Across Planning Themes




Figure J-16. Rank 14 Multiple Benefit Opportunity Across Planning Themes




Figure J-17. Rank 15 Multiple Benefit Opportunity Across Planning Themes




Figure J-18. Rank 16 Multiple Benefit Opportunity Across Planning Themes




Figure J-19. Rank 17 Multiple Benefit Opportunity Across Planning Themes




Figure J-20. Rank 18 Multiple Benefit Opportunity Across Planning Themes




Figure J-21. Rank 19 Multiple Benefit Opportunity Across Planning Themes




Figure J-22. Rank 20 Multiple Benefit Opportunity Across Planning Themes




Figure J-23. Rank 21 Multiple Benefit Opportunity Across Planning Themes




Figure J-24. Rank 22 Multiple Benefit Opportunity Across Planning Themes




Figure J-25. Rank 23 Multiple Benefit Opportunity Across Planning Themes




Figure J-26. Rank 24 Multiple Benefit Opportunity Across Planning Themes




Figure J-27. Rank 25 Multiple Benefit Opportunity Across Planning Themes




Figure J-28. Rank 26 Multiple Benefit Opportunity Across Planning Themes




Figure J-29. Rank 27 Multiple Benefit Opportunity Across Planning Themes




Figure J-30. Rank 28 Multiple Benefit Opportunity Across Planning Themes




Figure J-31. Rank 29 Multiple Benefit Opportunity Across Planning Themes




Figure J-32. Rank 30 Multiple Benefit Opportunity Across Planning Themes




Figure J-33. Rank 31 Multiple Benefit Opportunity Across Planning Themes




Figure J-34. Rank 32 Multiple Benefit Opportunity Across Planning Themes




Figure J-35. Rank 33 Multiple Benefit Opportunity Across Planning Themes




Figure J-36. Rank 34 Multiple Benefit Opportunity Across Planning Themes




Figure J-37. Rank 35 Multiple Benefit Opportunity Across Planning Themes




Figure J-38. Rank 36 Multiple Benefit Opportunity Across Planning Themes




Figure J-39. Rank 37 Multiple Benefit Opportunity Across Planning Themes




Figure J-40. Rank 38 Multiple Benefit Opportunity Across Planning Themes




Figure J-41. Rank 39 Multiple Benefit Opportunity Across Planning Themes




Figure J-42. Rank 40 Multiple Benefit Opportunity Across Planning Themes




Figure J-43. Rank 41 Multiple Benefit Opportunity Across Planning Themes




Figure J-44. Rank 42 Multiple Benefit Opportunity Across Planning Themes




Figure J-45. Rank 43 Multiple Benefit Opportunity Across Planning Themes




Figure J-46. Rank 44 Multiple Benefit Opportunity Across Planning Themes




Figure J-47. Rank 45 Multiple Benefit Opportunity Across Planning Themes




Figure J-48. Rank 46 Multiple Benefit Opportunity Across Planning Themes




Figure J-49. Rank 47 Multiple Benefit Opportunity Across Planning Themes




Figure J-50. Rank 48 Multiple Benefit Opportunity Across Planning Themes




Figure J-51. Rank 49 Multiple Benefit Opportunity Across Planning Themes




Figure J-52. Rank 50 Multiple Benefit Opportunity Across Planning Themes




Figure J-53. Rank 51 Multiple Benefit Opportunity Across Planning Themes




Figure J-54. Rank 52 Multiple Benefit Opportunity Across Planning Themes




Figure J-55. Rank 53 Multiple Benefit Opportunity Across Planning Themes




Figure J-56. Rank 54 Multiple Benefit Opportunity Across Planning Themes




Figure J-57. Rank 55 Multiple Benefit Opportunity Across Planning Themes




Figure J-58. Rank 56 Multiple Benefit Opportunity Across Planning Themes




Figure J-59. Rank 57 Multiple Benefit Opportunity Across Planning Themes




Figure J-60. Rank 58 Multiple Benefit Opportunity Across Planning Themes




Figure J-61. Rank 59 Multiple Benefit Opportunity Across Planning Themes




Figure J-62. Rank 60 Multiple Benefit Opportunity Across Planning Themes




Figure J-63. Rank 61 Multiple Benefit Opportunity Across Planning Themes




Figure J-64. Rank 62 Multiple Benefit Opportunity Across Planning Themes




Figure J-65. Rank 63 Multiple Benefit Opportunity Across Planning Themes




Figure J-66. Rank 64 Multiple Benefit Opportunity Across Planning Themes




Figure J-67. Rank 65 Multiple Benefit Opportunity Across Planning Themes




Figure J-68. Rank 66 Multiple Benefit Opportunity Across Planning Themes




Figure J-69. Rank 67 Multiple Benefit Opportunity Across Planning Themes




Figure J-70. Rank 68 Multiple Benefit Opportunity Across Planning Themes




Figure J-71. Rank 69 Multiple Benefit Opportunity Across Planning Themes




Figure J-72. Rank 70 Multiple Benefit Opportunity Across Planning Themes




Figure J-73. Rank 71 Multiple Benefit Opportunity Across Planning Themes




Figure J-74. Rank 72 Multiple Benefit Opportunity Across Planning Themes




Figure J-75. Rank 73 Multiple Benefit Opportunity Across Planning Themes




Figure J-76. Rank 74 Multiple Benefit Opportunity Across Planning Themes




Figure J-77. Rank 75 Multiple Benefit Opportunity Across Planning Themes




Figure J-78. Rank 76 Multiple Benefit Opportunity Across Planning Themes




Figure J-79. Rank 77 Multiple Benefit Opportunity Across Planning Themes




Figure J-80. Rank 78 Multiple Benefit Opportunity Across Planning Themes




Figure J-81. Rank 79 Multiple Benefit Opportunity Across Planning Themes




Figure J-82. Rank 80 Multiple Benefit Opportunity Across Planning Themes




Figure J-83. Rank 81 Multiple Benefit Opportunity Across Planning Themes




Figure J-84. Rank 82 Multiple Benefit Opportunity Across Planning Themes




Figure J-85. Rank 83 Multiple Benefit Opportunity Across Planning Themes




Figure J-86. Rank 84 Multiple Benefit Opportunity Across Planning Themes




Figure J-87. Rank 85 Multiple Benefit Opportunity Across Planning Themes




Figure J-88. Rank 86 Multiple Benefit Opportunity Across Planning Themes




Figure J-89. Rank 87 Multiple Benefit Opportunity Across Planning Themes




Figure J-90. Rank 88 Multiple Benefit Opportunity Across Planning Themes




Figure J-91. Rank 89 Multiple Benefit Opportunity Across Planning Themes




Figure J-92. Rank 90 Multiple Benefit Opportunity Across Planning Themes




Figure J-93. Rank 91 Multiple Benefit Opportunity Across Planning Themes




Figure J-94. Alhambra Multiple Benefit Opportunity Across Planning Themes




Figure J-96. Calabasas Multiple Benefit Opportunity Across Planning Themes




Figure J-97. Glendale Multiple Benefit Opportunity Across Planning Themes




Figure J-98. Hidden Hills Multiple Benefit Opportunity Across Planning Themes




Figure J-99. La Canada Flintridge Multiple Benefit Opportunity Across Planning Themes




Figure J-100. Los Angeles Multiple Benefit Opportunity Across Planning Themes




Figure J-101. Monterey Park Multiple Benefit Opportunity Across Planning Themes




Figure J-102. Pasadena Multiple Benefit Opportunity Across Planning Themes




Figure J-103. San Fernando Multiple Benefit Opportunity Across Planning Themes




Figure J-104. Santa Clarita Multiple Benefit Opportunity Across Planning Themes




Figure J-105. South Pasadena Multiple Benefit Opportunity Across Planning Themes




Figure J-106. Unincorporated LA County Opportunity for Multiple Benefits Across Planning Themes




Figure J-107. Supervisorial District 1 Multiple Benefit Opportunity Across Planning Themes




Figure J-108. Supervisorial District 2 Multiple Benefit Opportunity Across Planning Themes




Figure J-109. Supervisorial District 3 Multiple Benefit Opportunity Across Planning Themes




Figure J-110. Supervisorial District 4 Multiple Benefit Opportunity Across Planning Themes




Figure J-111. Supervisorial District 5 Multiple Benefit Opportunity Across Planning Themes

J.2 Opportunity to Improve Water Quality and Increase Water Supply

Outcomes from this composite opportunity analysis identified areas within the WA with the highest potential to Improve Water Quality and Increase Water Supply. Note, the relative opportunity classification (high, higher, highest) used in each map is defined in Appendix I.6.

To support various Program and Project proponent perspectives, analysis outcomes have been exported to several map sets across multiple scales:




Figure J-112. Rank 1 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-113. Rank 2 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-114. Rank 3 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-115. Rank 4 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-116. Rank 5 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-117. Rank 6 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-118. Rank 7 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-119. Rank 8 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-120. Rank 9 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-121. Rank 10 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-122. Rank 11 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-123. Rank 12 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-124. Rank 13 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-125. Rank 14 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-126. Rank 15 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-127. Rank 16 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-128. Rank 17 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-129. Rank 18 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-130. Rank 19 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-131. Rank 20 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-132. Rank 21 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-133. Rank 22 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-134. Rank 23 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-135. Rank 24 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-136. Rank 25 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-137. Rank 26 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-138. Rank 27 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-139. Rank 28 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-140. Rank 29 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-141. Rank 30 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-142. Rank 31 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-143. Rank 32 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-144. Rank 33 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-145. Rank 34 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-146. Rank 35 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-147. Rank 36 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-148. Rank 37 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-149. Rank 38 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-150. Rank 39 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-151. Rank 40 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-152. Rank 41 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-153. Rank 42 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-154. Rank 43 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-155. Rank 44 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-156. Rank 45 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-157. Rank 46 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-158. Rank 47 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-159. Rank 48 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-160. Rank 49 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-161. Rank 50 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-162. Rank 51 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-163. Rank 52 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-164. Rank 53 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-165. Rank 54 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-166. Rank 55 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-167. Rank 56 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-168. Rank 57 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-169. Rank 58 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-170. Rank 59 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-171. Rank 60 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-172. Rank 61 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-173. Rank 62 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-174. Rank 63 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-175. Rank 64 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-176. Rank 65 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-177. Rank 66 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-178. Rank 67 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-179. Rank 68 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-180. Rank 69 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-181. Rank 70 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-182. Rank 71 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-183. Rank 72 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-184. Rank 73 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-185. Rank 74 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-186. Rank 75 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-187. Rank 76 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-188. Rank 77 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-189. Rank 78 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-190. Rank 79 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-191. Rank 80 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-192. Rank 81 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-193. Rank 82 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-194. Rank 83 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-195. Rank 84 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-196. Rank 85 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-197. Rank 86 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-198. Rank 87 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-199. Rank 88 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-200. Rank 89 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-201. Rank 90 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-202. Rank 91 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-203. Rank 92 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-204. Rank 93 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-205. Rank 94 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-206. Rank 95 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-207. Rank 96 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-208. Rank 97 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-209. Rank 98 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-210. Rank 99 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-211. Rank 100 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-212. Rank 101 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-213. Rank 102 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-214. Rank 103 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-215. Alhambra Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-216. Burbank Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-217. Calabasas Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-218. Glendale Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-219. Hidden Hills Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-220. La Canada Flintridge Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-221. Los Angeles Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-222. Monterey Park Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-223. Pasadena Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-224. San Fernando Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-225. Santa Clarita Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-226. South Pasadena Opportunity for Improving Water Quality and Increasing Water Supply





Figure J-227. Unincorporated LA County Opportunity for Improving Water Quality and Increasing Water Suppl




Figure J-228. Supervisorial District 1 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-229. Supervisorial District 2 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-230. Supervisorial District 3 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-231. Supervisorial District 4 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-232. Supervisorial District 5 Opportunity for Improving Water Quality and Increasing Water Supply
