

Role of the Regional Oversight Committee & 2026 Biennial Progress Report

Primary Responsibilities:

- High-level review and assessment of the implementation of the Safe, Clean Water Program to help ensure that Program Purposes and Goals are met.
- Prepare and submit the Biennial Progress Report to the Board.





Purpose of SCW Program Biennial Progress Report

Ordinance 18.02: "SCW Program Progress Report" means a biennial report that summarizes all Regional Program WARPP Reports, all Municipal Program annual progress and expenditure reports, and all District Program annual reports and makes findings regarding whether and the extent to which SCW Program requirements were met and SCW Program Goals were achieved.





Data & Information Included in the 2026 Biennial Progress Report



Reported Data – FY2020-21 to FY2023-24 (July 1, 2020 to June 30, 2024)

• Reviews and evaluates the first four complete fiscal years of SCWP data, building on the 2024 Biennial Report with *last* two complete fiscal years of reported data.




Adaptive Management – To Date






SCWP <u>Regional Program</u> Reporting Informing 2026 Biennial Report (FY23-24 Shown)


SCWP **District Program** Administration & Implementation

- Facilitate the Regional Oversight Committee
- Oversee the Scoring Committee and nine Watershed Area Steering Committees (WASCs)—including formation, management, and facilitation
 - Support over **171** committee members, **12** Watershed Coordinators across the region
 - Facilitate approximately **80** public governance meetings annually
- Manage Technical Assistance Teams for Project concept development
- Oversee tax collection, tax relief programs, and fund disbursements for both the Regional and Municipal Programs






Municipal Program Funds Summary up to FY23-24 (6/30/24)

 - **December 31** Annual Report due for prior FY (*includes actual expenditures and progress*)




Regional Program Funds Summary up to FY23-24 (6/30/24)

Recommendations – Top Priorities (Slide 1 of 6)

1. Watershed Plans: Guiding Strategic Investments (Tier 1)

<u>Recommendation:</u> Integrate Initial Watershed Plans to guide strategic investments to achieve greatest impact.

2. Financial Forecasting, Funding Reserves & Leveraged Funding (Tier 1)

Recommendations: In time for the July 2027 Call for Projects, complete the following:

- a. Set standard and transparent methods for financial forecasting
- b. Set standard/minimum contingencies
- c. Further assess financial instruments/bonds (including outside grant opportunities)
- d. Regional Program Set interim funding cap of 80% for future years in the annual SIPs, and revisit cap annually for each WASC, based on the best available financial forecasts
- e. Regional Program Each SIP must include not less than 25% leveraged funding
- f. Municipal Program Evaluate fund accumulation and carryover policies



Recommendations – Top Priorities (Slide 2 of 6)

3. Monitoring Improvements & Greater Integration (Post-Construction and Integration with Regional Monitoring) (Tier 1)

Recommendations:

- a. Release Post-Construction Monitoring Guidance in Summer 2026
- b. Link Post-Construction Monitoring to existing processes and Watershed Planning in time for the July 2027 Call for Projects
- c. Coordinate with Regional Board to align water quality monitoring conducted through Municipal and Regional Program elements such as reporting, and report back to ROC in 2026
- d. Coordinate with County Departments and other agencies on monitoring programs and metrics, and report back to ROC in 2026
- e. Integrate metrics/monitoring into planning and reporting in time for the July 2027 Call for Projects



Recommendations – Top Priorities (Slide 3 of 6)

4. Increased Opportunities for Access & Participation (Tier 1)

Recommendation: Assess how a continuum of support can be provided to help all applicants access the Program.

5. Nature-based Solutions (NbS) (Tier 2)

Recommendation: Incorporate NbS definitions, standards, and performance measures into the SCW Program, using Blue-Ribbon Panel findings as a resource, and report back to the ROC during 2026.

- Continue convening NbS Task Force in 2026-27
- Develop performance measures with NbS Task Force
- Incorporate definitions, and, when available, newly developed metrics into:
 - Program Guidance documents
 - Feasibility Study Guidelines / Scoring Revisions
 - Reporting Module (as updated all by 2027)
 Note: All above recommendations are contingent on the timing and completion of NbS performance measures.

6. Refine Scoring (Tier 2)

<u>Recommendation:</u> Once Initial Watershed Plans are finalized, revisit and refine Regional Program scoring in 2026, in time for use during the July 2027 Call for Projects.



Recommendations – Top Priorities (Slide 4 of 6)

7. SCWP Governance Committee Appointments & Attendance (Tier 2, 3)

<u>Recommendation:</u> Expedite filling of vacancies for members/alternates and enforce maximum allowable absences. For establishing WASC quorum, lower the number of representatives from each category required – from 2 to 1 per category.

8. Municipal Staffing Challenges (Tier 3)

<u>Recommendation:</u> Increase capacity of Public Works staff to support municipalities and enhance services for SCW Program project development, with goal of having cities achieve a 100% timely performance of Municipal Program transfer agreements, annual plans, and reports.

9. Increased Transparency in Municipal Program Expenditure & Activities (Tier 1,3)

Recommendation: Integrate additional metrics and criteria for reporting and communicating contributions towards SCW Program Goals and expenditures for the 2026 reporting cycle.

Note: This recommendation is aligned with and related to. Recommendation #3 - Monitoring Improvements & Greater Integration (Post-Construction and Integration with Regional Monitoring)



Recommendations – Top Priorities (Slide 5 of 6)

10. Growing Program, Growing Administrative Workload (Tier 1,2,3)

Recommendations:

- Provide additional staff/resources
- Identify further opportunities to reduce complexities and gain improved efficiencies (e.g., AI engines)

11. District Education Programs (Tier 1,2,3)

Recommendations:

- a. Review and extend Public Education & Community Engagement Grants program or other similar opportunities
- b. Develop and deliver training program for elected officials and agency staff about SCW Program, in collaboration with appropriate partners and/or programs
- c. Make additional investments in Workforce Programs during 2026 and report back to ROC by June 2026
- d. Make additional investments in K-12 Programs and report back to ROC by June 2026
 - i. Hire consultant to evaluate existing educational programs and develop curriculum elements
 - ii. Invest directly in established programs like Generation Earth



Recommendations – Top Priorities (Slide 6 of 6)

12. Scientific Studies (Tier 1,2)

Recommendations:

- a. Establish a clearinghouse for scientific study information
- b. Create a Scientific Advisory Committee to review and score new scientific study proposals and propose future research topics.



Recommendations – Current Committed Efforts to Continue

1. Unspent Funds Accounting & Reporting

<u>Action:</u> New requirements in annual reporting to further identify unspent funds, interest accrued, and reason for unspent funds, along with any remedial actions.

2. CIB Targets & Interdepartmental Coordination/Integration

Action:

- Public Works is reaching out to agencies related to CIB targets and metrics as part of IWP revisions.
- An interagency task force (via an existing platform or new) will be used for ongoing coordination and to support adaptive management of the SCW Program. Report back to ROC on status by August 2026.


