





# Appendix J. Opportunity Maps

Projects and Programs that deliver multiple benefits are a cornerstone of the Safe, Clean Water (SCW) Program. While individual strategies can support specific SCW Program Goals, they are most effective when implemented together to create synergies across SCW Planning Themes. This appendix illustrates outcomes from the two composite opportunity analyses listed and described below<sup>1</sup>:

- **Section J.1 Multiple Benefit Opportunity Across Planning Themes.** This analysis highlighted areas within the Watershed Area (WA) with the highest potential to deliver multiple benefits across key SCW Program Planning Themes.
- **Section J.2 Opportunity to Improve Water Quality and Increase Water Supply.** This analysis highlighted areas within the WA with the highest potential to deliver dual benefits—specifically, to Improve Water Quality through pollutant load reduction and Increase Water Supply through stormwater capture.


The maps included in this appendix provide a static representation of the data that aligns with the progress of the Initial Watershed Plans at the time they were developed. For interactive versions of these maps with the most current information, users should use the [SCW Program Watershed Planning Tool](#) (Planning Tool). The Planning Tool is regularly updated to incorporate new data, recent investments, and changing watershed conditions; it serves as the preferred method for viewing and analyzing composite benefit opportunity areas<sup>2</sup>.

Figure J-1 and Figure J-2 illustrate the outcomes of the analyses described in Section J.1 and J.2, respectively, as visible on the Planning Tool. As illustrated in the figures, users can zoom in to areas of interest, toggle layers on the legend on the right-hand side of the map, then view details of specific features on the toolbar on the left-hand side of the map.



# J.1 Multiple Benefit Opportunity Across Planning Themes

The Multiple Benefit Opportunity Across Planning Themes composite opportunity identifies areas within the WA with the highest potential to deliver multiple benefits across key SCW Program Watershed Planning Themes (Improve Water Quality, Increase Drought Preparedness, Improve Public Health, Deliver Multi-Benefits with Nature-Based Solutions and Diverse Projects, and Equitably Distribute Benefits). Note, the relative opportunity classification (high, higher, highest) used in each map is defined in Appendix I.6.

To support various interested parties, Multiple Benefit Opportunity Across Planning Themes maps have been exported across multiple scales including:

- **Two-square-mile planning grids:** To highlight areas within the WA with the highest potential to deliver multiple benefits across key Planning Themes, two-square-mile planning grids are used. Maps for each grid cell within the WA are shown in Section J.1.1 from highest rank (i.e., highest relative opportunity) to lowest rank.
- **Municipalities:** To support targeted implementation by Project and Program proponents and Municipalities, maps for the Multiple Benefit Opportunity Across Planning Themes are exported at the municipal scale to highlight the opportunity levels within each. Maps for each municipality within the WA are shown in Section J.1.2.
- **Supervisorial Districts:** To support targeted implementation from the perspective of Supervisorial Districts, maps for the Multiple Benefit Opportunity Across Planning Themes are exported at the Supervisorial District scale to highlight the opportunity levels within each. Maps for each Supervisorial District within the WA are shown in Section J.1.3.




Figure J-3. Rank 1 for Multiple Benefit Opportunity Across Planning Themes




Figure J-4. Rank 2 for Multiple Benefit Opportunity Across Planning Themes

# USGR<sup>d</sup> WA Grid - Rank 3 for Multiple Benefit Opportunity Across Planning Themes




Figure J-5. Rank 3 for Multiple Benefit Opportunity Across Planning Themes




Figure J-6. Rank 4 for Multiple Benefit Opportunity Across Planning Themes




Figure J-7. Rank 5 for Multiple Benefit Opportunity Across Planning Themes




Figure J-8. Rank 6 for Multiple Benefit Opportunity Across Planning Themes




Figure J-9. Rank 7 for Multiple Benefit Opportunity Across Planning Themes



# USGR WA Grid - Rank 9 for Multiple Benefit Opportunity Across Planning Themes




Figure J-11. Rank 9 for Multiple Benefit Opportunity Across Planning Themes




Figure J-12. Rank 10 for Multiple Benefit Opportunity Across Planning Themes




Figure J-13. Rank 11 for Multiple Benefit Opportunity Across Planning Themes




Figure J-14. Rank 12 for Multiple Benefit Opportunity Across Planning Themes




Figure J-15. Rank 13 for Multiple Benefit Opportunity Across Planning Themes




Figure J-16. Rank 14 for Multiple Benefit Opportunity Across Planning Themes




Figure J-17. Rank 15 for Multiple Benefit Opportunity Across Planning Themes




Figure J-18. Rank 16 for Multiple Benefit Opportunity Across Planning Themes




Figure J-19. Rank 17 for Multiple Benefit Opportunity Across Planning Themes




Figure J-20. Rank 18 for Multiple Benefit Opportunity Across Planning Themes




Figure J-21. Rank 19 for Multiple Benefit Opportunity Across Planning Themes




Figure J-22. Rank 20 for Multiple Benefit Opportunity Across Planning Themes




Figure J-23. Rank 21 for Multiple Benefit Opportunity Across Planning Themes




Figure J-24. Rank 22 for Multiple Benefit Opportunity Across Planning Themes




Figure J-25. Rank 23 for Multiple Benefit Opportunity Across Planning Themes




Figure J-26. Rank 24 for Multiple Benefit Opportunity Across Planning Themes




Figure J-27. Rank 25 for Multiple Benefit Opportunity Across Planning Themes




Figure J-28. Rank 26 for Multiple Benefit Opportunity Across Planning Themes




Figure J-29. Rank 27 for Multiple Benefit Opportunity Across Planning Themes




Figure J-30. Rank 28 for Multiple Benefit Opportunity Across Planning Themes




Figure J-31. Rank 29 for Multiple Benefit Opportunity Across Planning Themes




Figure J-32. Rank 30 for Multiple Benefit Opportunity Across Planning Themes




Figure J-33. Rank 31 for Multiple Benefit Opportunity Across Planning Themes




Figure J-34. Rank 32 for Multiple Benefit Opportunity Across Planning Themes




Figure J-35. Rank 33 for Multiple Benefit Opportunity Across Planning Themes




Figure J-36. Rank 34 for Multiple Benefit Opportunity Across Planning Themes




Figure J-37. Rank 35 for Multiple Benefit Opportunity Across Planning Themes




Figure J-38. Rank 36 for Multiple Benefit Opportunity Across Planning Themes




Figure J-39. Rank 37 for Multiple Benefit Opportunity Across Planning Themes




Figure J-40. Rank 38 for Multiple Benefit Opportunity Across Planning Themes




Figure J-41. Rank 39 for Multiple Benefit Opportunity Across Planning Themes




Figure J-42. Rank 40 for Multiple Benefit Opportunity Across Planning Themes




Figure J-43. Rank 41 for Multiple Benefit Opportunity Across Planning Themes




Figure J-44. Rank 42 for Multiple Benefit Opportunity Across Planning Themes




Figure J-45. Rank 43 for Multiple Benefit Opportunity Across Planning Themes




Figure J-46. Rank 44 for Multiple Benefit Opportunity Across Planning Themes




Figure J-47. Rank 45 for Multiple Benefit Opportunity Across Planning Themes




Figure J-48. Rank 46 for Multiple Benefit Opportunity Across Planning Themes




Figure J-49. Rank 47 for Multiple Benefit Opportunity Across Planning Themes




Figure J-50. Rank 48 for Multiple Benefit Opportunity Across Planning Themes






Figure J-52. Rank 50 for Multiple Benefit Opportunity Across Planning Themes




Figure J-53. Rank 51 for Multiple Benefit Opportunity Across Planning Themes




Figure J-54. Rank 52 for Multiple Benefit Opportunity Across Planning Themes




Figure J-55. Rank 53 for Multiple Benefit Opportunity Across Planning Themes




Figure J-56. Rank 54 for Multiple Benefit Opportunity Across Planning Themes




Figure J-57. Rank 55 for Multiple Benefit Opportunity Across Planning Themes




Figure J-58. Rank 56 for Multiple Benefit Opportunity Across Planning Themes




Figure J-60. Azusa Multiple Benefit Opportunity Across Planning Themes




Figure J-61. Baldwin Park Multiple Benefit Opportunity Across Planning Themes




Figure J-62. Bradbury Multiple Benefit Opportunity Across Planning Themes





Figure J-63. Claremont Multiple Benefit Opportunity Across Planning Themes




Figure J-64. Covina Multiple Benefit Opportunity Across Planning Themes




Figure J-65. Diamond Bar Multiple Benefit Opportunity Across Planning Themes




Figure J-66. Duarte Multiple Benefit Opportunity Across Planning Themes




Figure J-68. Glendora Multiple Benefit Opportunity Across Planning Themes




Figure J-69. Industry Multiple Benefit Opportunity Across Planning Themes




Figure J-70. Irwindale Multiple Benefit Opportunity Across Planning Themes




Figure J-71. La Puente Multiple Benefit Opportunity Across Planning Themes








Figure J-74. Pomona Multiple Benefit Opportunity Across Planning Themes




Figure J-75. San Dimas Multiple Benefit Opportunity Across Planning Themes




Figure J-76. South El Monte Multiple Benefit Opportunity Across Planning Themes




Figure J-77. Unincorporated LA County Multiple Benefit Opportunity Across Planning Themes






Figure J-79. West Covina Multiple Benefit Opportunity Across Planning Themes





Figure J-80. Supervisorial District 1 Multiple Benefit Opportunity Across Planning Themes





Figure J-81. Supervisorial District 4 Multiple Benefit Opportunity Across Planning Themes

## J.2 Opportunity to Improve Water Quality and Increase Water Supply

This composite opportunity identifies areas within the WA with the highest potential to Improve Water Quality and Increase Water Supply. Note, the relative opportunity classification (high, higher, highest) used in each map is defined in Appendix I.6.

To support various interested parties, Opportunity to Improve Water Quality and Increase Water Supply maps have been exported across multiple scales including:

- **Two-square-mile planning grids:** To highlight areas within the WA with the highest potential to Improve Water Quality and Increase Water Supply, two-square-mile planning grids are used. Maps for each grid cell within the WA are shown in Section J.2.1 from highest rank (i.e., highest relative opportunity) to lowest.
- **Municipalities:** To support targeted implementation by Municipalities, the opportunity to Improve Water Quality and Increase Water Supply is exported at the Municipal scale to highlight the opportunity levels within each. Maps for each Municipality within the WA are shown in Section J.2.2.
- **Supervisory Districts:** To support targeted implementation from the perspective of Supervisory Districts, the opportunity to Improve Water Quality and Increase Water Supply was exported at the Supervisory District scale to highlight the opportunity levels within each. Maps for each Supervisory District within the WA are shown in J.2.3.




Figure J-83. Rank 1 for Improving Water Quality and Increasing Drought Preparedness




Figure J-84. Rank 2 for Improving Water Quality and Increasing Drought Preparedness




Figure J-85. Rank 3 for Improving Water Quality and Increasing Drought Preparedness




Figure J-86. Rank 4 for Improving Water Quality and Increasing Drought Preparedness




Figure J-88. Rank 6 for Improving Water Quality and Increasing Drought Preparedness





Figure J-89. Rank 7 for Improving Water Quality and Increasing Drought Preparedness




Figure J-90. Rank 8 for Improving Water Quality and Increasing Drought Preparedness




Figure J-91. Rank 9 for Improving Water Quality and Increasing Drought Preparedness





Figure J-92. Rank 10 for Improving Water Quality and Increasing Drought Preparedness




Figure J-94. Rank 12 for Improving Water Quality and Increasing Drought Preparedness




Figure J-95. Rank 13 for Improving Water Quality and Increasing Drought Preparedness




Figure J-96. Rank 14 for Improving Water Quality and Increasing Drought Preparedness




Figure J-97. Rank 15 for Improving Water Quality and Increasing Drought Preparedness





Figure J-98. Rank 16 for Improving Water Quality and Increasing Drought Preparedness




Figure J-99. Rank 17 for Improving Water Quality and Increasing Drought Preparedness





Figure J-100. Rank 18 for Improving Water Quality and Increasing Drought Preparedness




Figure J-102. Rank 20 for Improving Water Quality and Increasing Drought Preparedness




Figure J-103. Rank 21 for Improving Water Quality and Increasing Drought Preparedness




Figure J-104. Rank 22 for Improving Water Quality and Increasing Drought Preparedness




Figure J-105. Rank 23 for Improving Water Quality and Increasing Drought Preparedness




Figure J-106. Rank 24 for Improving Water Quality and Increasing Drought Preparedness




Figure J-107. Rank 25 for Improving Water Quality and Increasing Drought Preparedness




Figure J-108. Rank 26 for Improving Water Quality and Increasing Drought Preparedness




Figure J-109. Rank 27 for Improving Water Quality and Increasing Drought Preparedness




Figure J-110. Rank 28 for Improving Water Quality and Increasing Drought Preparedness




Figure J-111. Rank 29 for Improving Water Quality and Increasing Drought Preparedness




Figure J-112. Rank 30 for Improving Water Quality and Increasing Drought Preparedness




Figure J-113. Rank 31 for Improving Water Quality and Increasing Drought Preparedness




Figure J-114. Rank 32 for Improving Water Quality and Increasing Drought Preparedness




Figure J-115. Rank 33 for Improving Water Quality and Increasing Drought Preparedness




Figure J-116. Rank 34 for Improving Water Quality and Increasing Drought Preparedness




Figure J-117. Rank 35 for Improving Water Quality and Increasing Drought Preparedness




Figure J-118. Rank 36 for Improving Water Quality and Increasing Drought Preparedness




Figure J-119. Rank 37 for Improving Water Quality and Increasing Drought Preparedness




Figure J-120. Rank 38 for Improving Water Quality and Increasing Drought Preparedness





Figure J-121. Rank 39 for Improving Water Quality and Increasing Drought Preparedness

Figure J-122. Rank 40 for Improving Water Quality and Increasing Drought Preparedness




Figure J-123. Rank 41 for Improving Water Quality and Increasing Drought Preparedness




Figure J-124. Rank 42 for Improving Water Quality and Increasing Drought Preparedness





Figure J-125. Rank 43 for Improving Water Quality and Increasing Drought Preparedness




Figure J-127. Arcadia Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-128. Azusa Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-129. Baldwin Park Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-130. Bradbury Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-131. Claremont Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-132. Covina Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-133. Diamond Bar Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-134. Duarte Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-135. El Monte Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-136. Glendora Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-137. Industry Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-138. Irwindale Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-139. La Puente Opportunity for Improving Water Quality and Increasing Water Supply





Figure J-140. La Verne Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-141. Monrovia Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-143. San Dimas Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-144. South El Monte Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-145. Unincorporated LA County Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-146. Walnut Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-147. West Covina Opportunity for Improving Water Quality and Increasing Water Supply






Figure J-148. Supervisorial District 1 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-149. Supervisorial District 4 Opportunity for Improving Water Quality and Increasing Water Supply




Figure J-150. Supervisorial District 5 Opportunity for Improving Water Quality and Increasing Water Supply
