## 1) Welcome and Introductions

Douglas Krauss, Vice Chair of the South Santa Monica Bay (SSMB) Watershed Area Steering Committee (WASC), welcomed Committee Members and called the meeting to order.

Los Angeles County Public Works (Public Works) staff facilitated Committee Member introductions and established quorum. Public Works staff provided a brief WebEx tutorial and instructions on public comment submissions.

## 3) Discussion

### a) Workforce Development

Presentation by Jolene Guerrero, Deputy Director for Water Resources at Los Angeles County Public Works

Jolene Guerrero (Public Works) gave an overview of the SCW Program's Workforce Development Program, intended to create local job training and career pathways that support the construction, operation, and maintenance of stormwater projects. Member Susie Santilena thanked Public Works for their workforce development efforts and asked for clarification on workforce parameters and vacancy types for participating agencies. Guerrero explained that workforce needs are primarily focused on green infrastructure, with opportunities ranging from entry-level roles to long-term career pathways.

Watershed Coordinator Nancy Shrodes asked how community members would access training and workforce programs and whether outreach materials would be available. Guerrero noted that elements of the program are anticipated to be launched within the year and that outreach materials will be developed to support local hiring.

#### b) Infrastructure Program Presentations

##### i. Darby Park Multi-Benefit Project

Presentation by Brenda Ponton (City of Inglewood)

Brenda Ponton (City of Inglewood) presented the Darby Park Multi-Benefit Project. Presentation slides are available on the [SCW Program website](#). The Project will capture, treat, and infiltrate stormwater from the 84-acre drainage area using dry wells and related infrastructure to improve water quality in the Dominguez Channel Watershed. In addition to hydrologic benefits, enhancements at Darby Park will include upgraded park amenities such as exercise areas, shade, seating, signage, pathways, and landscape improvements, with associated public outreach and educational opportunities. The Project emphasizes community benefits, green infrastructure, and pollutant load reductions, and includes cost-sharing from the City of Inglewood.

Member Santilena asked whether the applicant had developed a backup plan if the preferred infiltration approach is infeasible. Ponton indicated that the preferred alternative involves deep dry wells, which have been confirmed with geotechnical studies. A nearby sewer line was noted as a secondary option but is not large and would require pumping.

Member Geremew Amenu asked about the drainage area and the number of dry wells. Ponton confirmed that there would be 24 dry wells for the 4.4-acre-foot system.

Member Amenu questioned the need for the gallery and its drainage capacity, noting that its cost should be carefully considered if it is not necessary for source infiltration. Ponton explained that the gallery addresses peak flow management, as the Project's dry wells would manage all flow, based on lessons learned from previous County Projects. Ponton further clarified that the infiltration gallery would serve both pretreatment and gravity flow purposes.

##### ii. Los Angeles Harbor College Stormwater Projects

Presentation By Daniel Apt (Olaunu)

Daniel Apt (Olaunu) presented the West Los Angeles College Stormwater Improvements Project. Presentation slides are available on the [SCW Program website](#). The Project consists of five stormwater BMPs treating five separate drainage areas, including dry wells and biofiltration units. Project goals include functional treatment of stormwater runoff, enhanced aesthetics and reduction of the heat island effect through incorporation of the vegetated biofiltration areas, significant reduction in stormwater related pollutants, and educational opportunities regarding the benefits of sustainable stormwater management.

Member Vanessa Hevener noted that the Project site consists mostly of open space with very few acres of parking lot, while the offsite area consists of a golf course, and asked the applicant to highlight the pollutants of concern at the site. Apt noted that while infiltration at the site is limited due to predominantly clay soils, a fair amount of runoff is expected.

Member Santilena expressed Los Angeles Sanitation & Environment's support for the Project and emphasized the importance of the Project's intention to capture offsite runoff on a school campus, noting coordination challenges with the Los Angeles Unified School District.

Upon inquiry, Apt confirmed that the golf course is a municipal course owned by the City of Los Angeles.

Member Dave Pierce noted that the funding request is structured to address any potential issues, and that reimbursement through Measure W is possible.

Member CJ Caluag asked about operations and maintenance (O&M) funding. The applicant confirmed that O&M will be fully covered by the Los Angeles Community College District, with no future funding request anticipated.

#### 4) Approval of Meeting Minutes from December 17, 2025

Vice Chair Krauss presented the SSMB WASC meeting minutes from December 17, 2025. Member Margie Hoyt motioned to approve the meeting minutes, seconded by Member Santilena. The WASC voted to approve the meeting minutes with 13 votes in favor, 2 in abstention, and 0 opposed (approved, see vote tracking sheet attached).

#### 5) Committee Member and Program Updates

Member CJ Caluag will be taking over from Member Marcela Benavides as the primary for Los Angeles County Flood Control District for the SSMB WASC.

Public Works staff provided updates, noting:

- Three Scientific Study applications were deemed ineligible. Two of the three ineligible applications were focused on workforce development. Applicants have been notified of the SCW Program's decision. Workforce development remains a key component of the SCW Program. The SCW Program Scientific Symposium recording is available on the [program website](#) to provide additional guidance.
- Of 29 Infrastructure Program (IP) Projects scored, 26 are being considered for inclusion in the SIP. Program-wide, three IP Projects did not pass the Scoring threshold.
- Project Modification Reports (PMRs) are collected year-round, with an October 31 submission deadline. Updates will be provided to each WASC at a future meeting, and Mid-Year Reports are due February 15.
- Eight Watershed Coordinator contracts have been finalized. Four remain pending, with two in finalization and two still under review.
- Program updates, guidance documents, and application materials are available on the [SCW Program website](#) to support applicants, Project managers, and partners.

Upon inquiry, Public Works staff confirmed that the Application Module will be updated prior to the next Call for Projects deadline, and functionality issues will be addressed. Subsequent changes to the Scoring Criteria are anticipated for the 2027 Call for Projects.

Member Santilena referenced the Regional Oversight Committee's (ROC) Biennial Progress Report, and highlighted challenges with Projects passing the Scoring threshold in certain Watershed Areas. Member Santilena asked if it would be appropriate to advocate for WASC-specific Scoring thresholds. Ryanna Fossum (Regional Coordination) noted that the public comment period is open and that comments can be submitted from WASC Members, including feedback related to watershed area-specific Scoring.

Member Caluag inquired about the PMR submitted for SSMB and the timing for updates to the SIP tool. Public Works staff indicated that the tool is scheduled for release at the end of next week and will be available prior to the next meeting.

#### 6) Watershed Coordinator Updates

Watershed Coordinator Shrodes shared an update on Watershed Coordinator activities. Watershed Coordinator Shrodes met with a local landscape architecture firm to explore potential collaboration opportunities and continued coordination with Living Stormwater to identify additional partnership and outreach opportunities. Watershed Coordinator Shrodes also attended a ROC meeting and encouraged Committee Members to provide feedback on the Biennial Report.

The Watershed Coordinator participated in the Los Angeles County Regional Water Reliability Task Force to learn more about Task Force objectives and public engagement opportunities.

Watershed Coordinator Shrodes also noted upcoming outreach and education efforts, including planning for the Pasadena Green Schoolyard initiative and a May 13 event at the Natural History Museum focused on harvesting. A Baldwin Hills watershed planning meeting is anticipated in March, focusing on Watershed Planning, the SCW Program, and coordination with the Baldwin Hills Conservancy. Proposition 4 grant guidelines were also released and made available through the Conservancy.

Watershed Coordinator Shrodes also attended training on moving beyond land acknowledgements, which addressed historical erasure and resource inequities and explored actionable steps for more inclusive tribal engagement practices. Additional updates included future participation in Whale Fiesta outreach activities.

#### 7) Public Comment Period

Public Works received six public comment cards, which are available on the [SCW Program website](#).

Jessica Rivas (City of Pasadena) commented on the City of Pasadena's Workforce Development Study and outreach and the need to develop a trained workforce at the same pace at which green infrastructure is being constructed. Rivas noted that the City of Pasadena has committed \$500,000 local dollars to the continued development of their proposed Study and encouraged stakeholders to reach out to the City of Pasadena to stay engaged with these efforts.

Amanda Pollack (Center for Watershed Protection) commented on the Center for Watershed Protection's history of leadership in stormwater management and professional training. Pollack highlighted the Center's workforce development efforts and pathways to provide stormwater maintenance training and credentials. Pollack expressed excitement about the Center's partnership with the City of Pasadena and commitment to expanding high-quality workforce development opportunities across the region.
