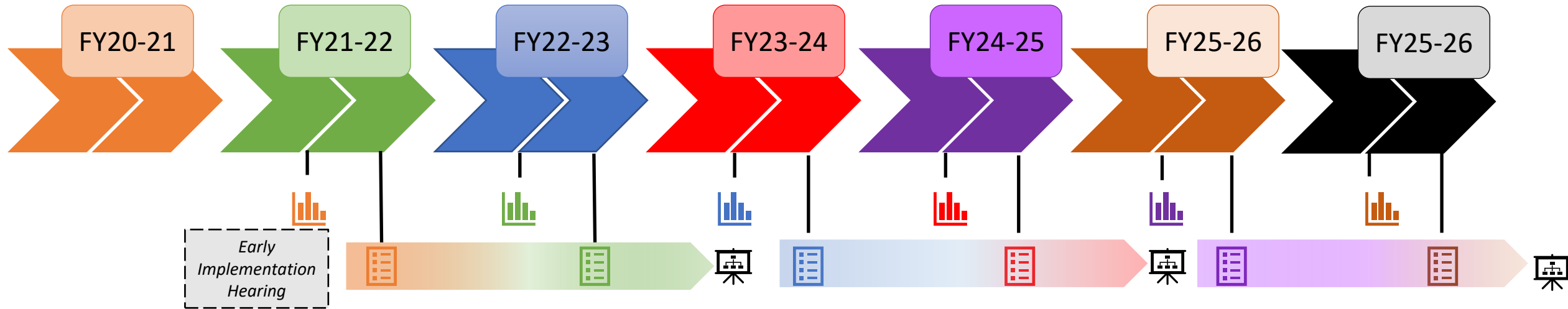


SCW Program Reporting Timeline



- Annual reports are due December 31st (Regional, Municipal, and District Programs)
 - First due 12/31/2021



- WASC will prepare WARPP Reports due annually (6-months after Annual Reports – June 30th)
 - Covers Regional Program – IP, TRP, SS Programs
 - First report due 6/30/2022



- ROC will prepare Biennial Reports due every two years (6-months after WARPP report for 2nd year- December 31st)
 - Covers Regional, Municipal, and District Programs
 - First Biennial Report due 12/31/23 and due every two years thereafter.
 - *Note: To facilitate program review prior to formal reporting, an “early implementation” public hearing is anticipated late Summer 2021.*

Municipal Program Timeline



- 1st Annual Plan due 45-days after executed agreement



- Disbursements typically around late August each year
(First year disbursement 45-days after agreement signed)



- For 2nd year and beyond, Annual plan due every April 1



- Annual Report due every Dec 31 (6 months after end of County FY)

























- Audit due 9 months after the 3rd year (occurs every 3 years)
 - First audit FY 23-24 to cover FY 20-21, 21-22, 22-23
 - Second audit occurs FY 26-27 to cover FY 23-24, 24-25, 25-26





- Funds lapse 5 years after end of FY (Year 1 funds considered lapsed after year 5), with potential 12-month extension if request is received no later than 3 months before funds lapse.

- Annual Report due 6 months after end of County FY (December 30)
 - First annual report due 12/31/21



- Audit due 9 months after the 3rd year (occurs every 3 years)
 - First audit occurs FY 22-23 to cover FY 19-20, 20-21, 21-22
 - Second audit occurs FY23-24 to cover FY 22-23
 - Third audit occurs FY 26-27 to cover FY 23-24, 24-25, 25-26

Regional Program Timeline



- Scope of Work due 45-days after BOS approval of SIP
 - For Year 1, approval on 10/13; SOWs (Exhibit A) due end of November



- Disbursements (Exception = when a Project is entering construction)



- Quarterly Report due 45-days following the end of the calendar quarter:

<u>Quarter</u>	<u>End of Quarter</u>	<u>Report Due</u>
First Quarter	September	15 November
Second Quarter	December	15 February
Third Quarter	March	15 May
Fourth Quarter	June	15 August



- Annually, summary of Quarterly reports (i.e., WARPP) due Dec 31 (6-months after the close of Q4)


















































- Audit due 9-months after Activity Completion and may occur every 3-years (District discretion)
 - First audit FY 23-24 to cover FY 20-21, 21-22, 22-23
 - Second audit occurs FY 26-27 to cover FY 23-24, 24-25, 25-26



- Lapsed funds (Year 1 funds considered lapsed after year 5) to allow a 12-month extension if request is received no later than 3 months before funds lapse.
