### Comments

While considering your full scope for the Safe, Clean Water Program work on the Upper LA River at North Hollywood Park (Recreation Center), it would be a great benefit for the community if you would consider putting some funding into a new roller rink and bathroom facilities on the West side of the park.

As a builder who works primarily on affordable projects (a current project downtown includes subsidized housing and a YMCA near 4th and Vermont), I can't express enough how facilities like this benefit the community and our youth.

Frank Delessandro with Cage Hockey does a fantastic job of making roller hockey affordable and available to all youth including providing equipment and very low, sometimes no cost to play, helping to keep kids entertained, get exercise and stay out of trouble.

Having had two children play ice hockey at a high club level, I've likely spent over \$100K in the last 10 years which is something many families could not afford.

Roller hockey is the next best thing and most week nights and every weekend, the current rink is crowded with children, parents and adults playing or watching roller hockey.

An updated facility and additional bathroom facilities on that side of the park would allow for even more kids/people to be involved in a Southern California setting that often does not have much available at low cost for the general public. Please consider these points in your planning.
