1. Welcome and Introductions

LA County Flood Control District (District) staff provided a brief WebEx tutorial in both English and Spanish and announced that the meeting was being broadcast live in Spanish. District staff welcomed Committee Members and called the meeting to order.

District staff facilitated the roll call of Committee Members. All Committee Members made self-introductions and a quorum was established.

2. Approval of Meeting Minutes from January 11, 2023 and January 19, 2023

Member Yazdan Emrani motioned to approve meeting minutes from both January 11, 2023 and January 19, 2023. Member Genevieve Osmena seconded the motion. The WASC approved the January 11, 2023 meeting minutes with 14 in favor and 0 opposed, and the January 19, 2023 meeting minutes with 13 in favor, 1 abstention, and 0 opposed (approved, see vote tracking sheet).



3. Ex Parte Communication Disclosures

There were no ex parte communications.

4. Committee Member and District Updates

There were no updates from Committee Members.

District staff provided an update:

- On January 10, the Board of Supervisors (Board) voted to continue meeting virtually, acting under the authority of Assembly Bill 361 which authorizes public committees to meet without complying with all the teleconferencing requirements of the Brown Act when the situation warrants it. The Board is reviewing its position every 30 days. If the Board decides to no longer approve findings to continue teleconferencing meetings under AB 361 and there is still a State of Emergency in place, the WASC has the authority to make their own AB 361 findings. District staff will provide additional guidance if that occurs.
- The District released the Regional Program Process Funding Handbook (Handbook). The Handbook provides consolidated information on existing regional program requirements and guidance. The Handbook is available under the Regional Program Call for Projects tab on the Safe, Clean Water Program (SCWP) website (<u>safecleanwaterla.org</u>).
- Emails have been sent to the project developers for Funds Transfer Agreements and Funds Transfer Agreement addendums for Fiscal Year 2022-2023 (FY 22-23) Stormwater Investment Plans (SIPs) fund disbursements.
- Quarterly Reports for FY22-23 covering October to December of 2022 activities are due February 15, 2023 for Round 1 and Round 2 Infrastructure Program (IP) Projects and Scientific Studies (SS). Regional Quarterly Reports must be completed even if there was no activity done on the project and if the transfer agreements have not yet been executed. To view Quarterly Reports, visit the <u>SCW Portal</u> Dashboard, select a project, then select Project Reports.
- Annual Plans for Municipal Programs are due April 1, 2023.
- WASC Stakeholder seats are up for reappointment August 2023, under Article 4, Section 5 of the WASC operating guidelines. Individuals interested in serving as a Community Stakeholder should submit the Interest to Serve Form, <u>available here</u>.
- Attending meetings regularly is a requirement for WASC members under Article 5 of the WASC Operating Guidelines. An absence of two consecutive meetings or more than five meetings in one year will be considered failure to attend meetings and may result in the absentee member's removal from the WASC. If attendance by the primary member is not possible for a particular meeting, it is requested that the Alternate member be present at the meeting.

The Committee asked for clarification on the return of in-person WASC meetings. District staff shared that as of February 28, 2023, the State of Emergency for COVID-19 will end, and they have secured meeting venues through June of 2023. District staff added that the meetings will mostly be in the Los Angeles County Public Works headquarters building at 900 S Fremont Ave, Alhambra, CA 91803. District staff noted that hybrid options may be available for project developers and other constituents, but that Committee Members are highly recommended to attend in person. More details will be shared with the WASC and posted on the ULAR WASC webpage as they become available.

Member Veronica Padilla-Campos asked District staff if there is still opportunity to provide recommendations for the SCWP website, and District staff confirmed. Recommendations can be provided to <u>SafeCleanWaterLA@pw.lacounty.gov</u>.

5. Watershed Coordinator Updates



Watershed Coordinator Adi Liberman updated the Committee on past and upcoming events. See slides available on the SCWP website for details.

On March 1, 2023, the Watershed Coordinators will participate at the Los Angeles Business Council meeting, followed by a water resiliency workshop for the Los Angeles Federation of Businesses on March 24, 2023.

The Watershed Coordinators received a lot of engagement with the newsletter they recently distributed. The WASC is encouraged to pass along the newsletter to others who may benefit from its content.

Recently, ULAR Watershed Coordinators:

- Coordinated with other Watershed Coordinators to discuss interdisciplinary water topics at their monthly Watershed Coordinator gatherings, which recently included a robust conversation on homelessness and stormwater in Los Angeles.
- Presented for the Local Resident Water Committee by East Yard Communities for Environmental Justice and shared information to the Water Committee on local projects that are funded by SCWP.
- Met with Altadena Action Now to engage residents interested in green infrastructure, green streets, and water supply (February 1, 2023)
- Met with Black Thumb Farm in Panorama City (February 2, 2023)

On the topic of past and upcoming site visits, ULAR Watershed Coordinators shared:

- The City of San Fernando Valley conducted a tour at Rudy Ortega Park, where educational opportunities through SCWP were shared with participants.
- February 6, 2023: ULAR Watershed Coordinators will host a site tour in East Los Angeles Park with the non-profit Legacy LA.
- The ULAR Watershed Coordinators will co-host a Magic Johnson Park site tour with Los Angeles County Public Works, the Park Equity Alliance, and other community-based organizations.
- In the Spring, tours will be held for regional projects like the Tujunga Spreading Grounds, Rory M. Shaw, and South Los Angeles projects.

Watershed Coordinator Moran encouraged the WASC to let the Watershed Coordinators know if any ideas arise for other site tours.

6. Public Comment Period

District staff compiled all public comment cards received by 5:00pm the day before the meeting, uploaded them to the SCWP website, and displayed them on-screen. Participants on the Spanish translation line and call-in users were also invited to provide public comment.

Kelsey Jessup (The Nature Conservancy) provided a public comment card regarding the Bowtie Demonstration Project. Jessup mentioned that the project application document and public comment card were submitted prior to deciding that additional surveys were not necessary for the project. Jessup shared that members of the community have communicated to their team that they feel burdened by the quantity of surveys and requests for providing information. Jessup mentioned that this input is relevant to Agenda Item 7.a.ii.

7. Presentations and Discussion Items

a. Infrastructure Program (IP) Project Presentations (SCW Portal)



i. Arroyo Seco Projects Presentation by City of South Pasadena

Ted Gerber (Public Works Director, City of South Pasadena) and Jon Abelson (Consultant, Stantec) shared a presentation about the project. The three regional stormwater capture and treatment facilities aim to treat both wet and dry weather runoff within an open space near the Arroyo Seco Channel in South Pasadena. The project has received TRP funds in the past.

The Committee asked if technical and/or feasibility studies have been conducted yet. Abelson confirmed that analyses were conducted to ensure site feasibility and added that the pre-existing water system will not be altered, but flows may be higher due to increased runoff.

Member Max Liles asked for the reasoning behind submitting a single application for all the Arroyo Seco Projects as opposed to submitting three separate project applications. The applicants explained that the sites are interconnected through the water infrastructure system, so it made sense to apply for funding as one project.

Member Padilla-Campos requested more information about the golf course on the project's site, and Gerber shared that the golf course is city-owned and available to the public, meaning that it is open for use to neighbors and local community groups.

Chair Teresa Villegas asked for clarification on the project funding request after the first two years of funding. The project applicants shared that additional funding will be sought out in the third and fourth years of project implementation.

ii. Bowtie Demonstration Project (Updated) Presentation by The Nature Conservancy

Kelsey Jessup (Urban Conservation Project Director, The Nature Conservancy) presented on the project. Jon Abelson (Consultant, Stantec) was available to answer questions for this presentation. The project aims to implement a multi-benefit stormwater management and habitat enhancement project along the Los Angeles River.

The Committee asked the project applicants about the permits required for developing habitat on the parcel, and if permitting processes are already under way. Jessup noted that the site is operated by California State Parks, meaning that ongoing maintenance will be a collaborative effort. Abelson added that since water will be used for irrigation, they will be coordinating with LA County Department of Public Health. The project applicants shared that since the wetland will be constructed rather than naturally occurring, it is not covered by certain protections and the CEQA process will confirm this. Jessup also noted that LA Department of Water and Power has an easement near the site and conversations are underway with related parties to fulfill NEPA requirements with the Army Corps of Engineers.

The Committee also discussed site design and its access to neighborhood residents. The project applicants highlighted that California State Parks will be designing and developing clear entryways to the site.

iii. Emerald Necklace John Muir High School Campus Natural Infrastructure Improvement Project Presentation by Claire Robinson, Amigos de los Rios

Claire Robinson (Project Applicant, Amigos de los Rios) and Mike Rudd (Consultant, Geosyntec) presented the project. The project will provide campus and neighborhood stormwater management, drainage, and public health benefits by integrating nature-based infrastructure on a school campus.



Member Osmena asked if the school currently has any flood-prone areas and whether the school itself will be taking on the operations and maintenance long-term. Robinson confirmed that the school does experience nuisance flooding because it is a large campus. Robinson added that long-term care of the facilities will be split between Amigos de los Rios and the school, and Amigos de los Rios will oversee the dry well. Robinson added that they would apply for more SCWP funds after the first 5 years of project implementation.

Member Mark Lombos asked if the volume of water captured on-site versus off-site has been quantified, and Rudd shared that the specified numbers should be noted in the feasibility study documents.

Member Ernesto Pantoja asked if the project will be built under a Project Labor Agreement and whether local community members will have the opportunity to work on the project and potentially build a green career from those opportunities. The project applicants shared that they hope to work closely with State and local Conservation Corps teams to include youth and career mentors in green career development. Robinson also added that maintenance and care of the nature-based solutions will be conducted through collaborative events between Amigos de los Rios and Pasadena Unified School District, providing opportunities for students and community members from different campuses to come together.
