1. Welcome and Introduction

LA County Flood Control District (District) staff provided a brief WebEx tutorial for individuals joining online. David Pedersen, Chair of the North Santa Monica Bay (NSMB) Watershed Area Steering Committee (WASC), welcomed Committee Members and called the meeting to order. All Committee Members made self-introductions and a quorum was established.

2. Approval of Meeting Minutes from February 9, 2023

Chair Pedersen presented the minutes from the previous meeting. Member Joe Bellomo motioned to approve, seconded by Member Tevin Schmitt. The WASC voted to approve the February 9, 2023 meeting minutes with 8 votes in favor, 0 opposed, 3 in abstention, and 1 member absent at the time of vote (approved, see vote tracking sheet).

3. Committee Member and District Updates

District staff provided an update, noting:

 The COVID-19 State of Emergency ended on February 28, 2023. To ensure quorum and effective communication during critical Stormwater Investment Plan (SIP) deliberations such that all

Committee Members can participate equally, Committee Members are highly encouraged to attend in person or send an alternate to attend in their place. If the meeting venue can accommodate hybrid meetings, Committee Members may have the option to attend virtually in a manner that is compliant with the full Brown Act and/or Assembly Bill (AB) 2449.

- The first term for WASC Community Stakeholder seats will end at the conclusion of Fiscal Year 2023-2024 (FY23-24). Community Stakeholders interested in joining the WASC for the next 3-year term should submit the interest to serve form. Current seat holders interested in reapplying do not need to submit another form. The link to the form is available at the bottom of the first page of this meeting agenda and here.
- All WASCs have finalized their SIP recommendations for FY23-24. The Regional Oversight Committee is scheduled to meet and begin reviewing all nine SIPs on April 20, 2023.
- The District has released the Regional Program Funding Process Handbook. The handbook provides consolidated information on existing Regional Program requirements and guidance. The handbook is available under the Regional Program – Call for Projects tab on the Safe, Clean Water Program (SCWP) website.
- Municipal Annual Plans were due April 1, 2023. District Staff will contact members whose submittal
 is still pending.

4. Watershed Coordinator Updates

Watershed Coordinator Melina Sempill Watts provided an update about recent and upcoming outreach efforts in facilitating community engagement, identifying and developing project concepts (with particular mention of community-driven projects and partnership opportunities), working with technical assistants, facilitating identification and representation of community priorities, integrating priorities through partnerships and extensive networks (noting the importance of continuing to build relationships), leveraging funding and cost-share partners, continuing educational efforts, and collaborating with other watershed coordinators. Watershed Coordinator Watts reminded the WASC that there are a lot of funds through Measure W that have not been spent yet. Upcoming events are included under Agenda Item 6d. Lastly, Watershed Coordinator Watts introduced Angelique Higgins, a new member of Sempill Watts Consulting LLC. See slides available on the SCWP website and attached.

The Committee discussed the possibility for partnering with the California Department of Transportation (Caltrans). Watershed Coordinator Watts and Mike Antos (Stantec, Regional Coordination) shared that Caltrans is required to comply with waste load allocation reductions, so they are incentivized to become funding partners to projects that can contribute to their compliance with the permit. Caltrans has access to federal funding for such activities, and they need projects to partner with. The WASC requested a future agenda item presentation on Caltrans programs and Vice Chair Madelyn Glickfeld suggested scheduling conversations with Caltrans to discuss the matter further, particularly regarding potential work along state highways. Chair Pedersen will invite Caltrans to provide an update on existing programs at a future meeting.

5. Public Comment Period

District staff compiled all public comment cards received by 5:00pm the day before the meeting. No comment cards were received before the meeting. There were no public comments.

6. Discussion

a) Ex Parte Communication Disclosure

Member Jessica Forte disclosed a meeting including Watershed Coordinator Watts, Member Roxanne Hughes, and others, to discuss and plan the upcoming State of the Watershed event.

Watershed Coordinator Watts noted that even if there is no quorum, there is still interest in holding the NSMB WASC meetings. Participants of this meeting agreed that the WASC meetings play an important role in project development, and so should be held even with a smaller group of people present.

b) Q&A Discussion for the Regional Pathogen Reduction Study Richard Watson, Gateway Water Management Authority

Richard Watson (Gateway Water Management Authority) shared an update on the Regional Pathogen Reduction Study at the request of the WASC. Watson reminded the WASC about the goals of the study which leverages recent research to develop better proxies for pathogens that cause human illness, as compared to the fecal coliform indicator. The study is included in all nine Watershed Area SIPs, and they have started the process of generating and executing transfer agreements. The team plans to establish a Stakeholder Committee inclusive of representatives from environmental non-governmental organizations (NGOs), the State and Regional Water Quality Control Boards, and possibly the United States Environmental Protection Agency.

Upon request for clarification regarding the difficulties associated with wet weather compliance requirements, Watson noted that their process will include acquiring an extension of compliance from the Regional Board.

Watson shared the tentative list of proxies under development which includes norovirus, coliphage, and others. The list also includes the HF183 human marker, but Watson noted the associated complexity of false positives. The fecal coliform indicator will continue to be monitored to use as a control and standard of comparison for the other proxies. Watson added that work is underway to prepare laboratories to handle more sophisticated testing kits.

When asked about whether the study would include markers for animals such as horses, Watson replied that the Stakeholder Committee will make that determination.

Vice Chair Glickfeld emphasized the time-critical nature of this research and recommended that the study team consider building in actions that will yield short-term benefits, not just the long-term.

Watershed Coordinator Watts recommended adding feline markers to the study, which Watson said he would relay to the Stakeholder Committee, where decisions will be made to come to agreement on the markers which are most significant to all residents and beneficiaries.

c) NSMB WASC EWP Project Updates Melina Watts, NSMB Watershed Coordinator

Watershed Coordinator Watts provided an overview of the NSMB Watershed cities' utilization of SCWP funds, including actual and potential funding allocations. Cities include Agoura Hills, Calabasas, Hidden Hills, Malibu, and Westlake Village. Watershed Coordinator Watts shared details about two projects in Malibu (Zuma Beach parking lot and Broad Beach shoreline restoration, beach habitat creation, and water capture) and potential partnerships. See slides available on the SCWP website and attached.

Member Forte shared an update about the project in the City of Agoura Hills which previously failed to receive SCWP funds due to the Scoring Committee disagreeing with the cost calculations in the proposal. Funds have since been received through the City and they are confident that they will meet the scoring criteria when they apply for the next round.

Antos encouraged the Committee to use this moment to reflect on ways to seek projects from other entities in the region, now seeing the progress each of the cities is making.

The Committee discussed the possibility of partnering with school districts to develop water quality projects for kids. Watershed Coordinator Watts shared that while there is interest from schools, they have heard that the districts are overworked, and the process is complicated.

Member Glickfeld shared an example of what to avoid, when conducting project work that impacts nearby communities. The Los Angeles County Department of Beaches and Harbors used Point Dune State Beach as a staging area, dumping truckloads of rocks, disturbing the sand dunes, and harming the beach. All this created conflict with the community. Member Glickfeld emphasized the importance of following appropriate procedures to disturb communities as little as possible during project development.

Watershed Coordinator Watts commented that a project at Rindge Dam resulted in the availability of approximately 800,000 cubic feet of beach quality sediments that may be helpful to the City of Malibu for habitat and shoreline restoration. This will be presented at the State of the Watershed event on May 11, 2023 and attendance is encouraged.

d) Potential Dates for Outreach Events

e) Updated North Santa Monica Bay Strategic Outreach and Engagement Plan

Watershed Coordinator Watts provided an overview of the draft update for the SOEP. The plan consists of 25 strategies that address nine tasks for the watershed coordinator and 14 goals in Measure W. Watershed Coordinator Watts shared suggestions and efforts related to these strategies. See slides available on the SCWP website and attached.

Antos shared that work is underway with coordinators across the program to strengthen the commitment to Tribal engagement and use appropriate language in strategic plans.

Member Hughes shared that there is a small Homeowners Association (HOA) that is working in the development of a HOA council where all HOAs can share lessons learned, knowledge and solutions. Member Forte commented that some HOAs expressed interest in spreading education and asked Watershed Coordinator Watts for her support in this matter.

Upon inquiry, District Staff clarified that the SOEP must be approved by the WASC every year.

7. Public Comment Period

There were no public comments.




