

Safe, Clean Water Program- Program Goals & Equitable water system

The Safe, Clean Water Program (SCWP) provides dedicated funds to increase LA County's local water supply, improve water quality, and increase overall public health. To prioritize these efforts, a series of goals were developed with the help of public health groups, environmental groups, cities, businesses, labor, and community-based organizations. By pursuing these goals, LA County can be at the forefront of adaptation and increase its water resilience.

Safe, Clean Water Program Goals

- Develop stormwater capture projects throughout LA County to capture more of the billions of gallons of water we lose every year.
- Help keep trash and other pollutants harmful to life from entering our coastal waters and beaches.
- Modernize LA County's water infrastructure using nature, science, and new technology.
- Increase public health by developing projects with community benefits in mind, including the access to safe, clean water.
- Prepare LA County for the effects of a changing climate, including the possibilities of droughts, wildfires, and flooding.

Together, these goals focus on updating LA County's 100-year-old water system by placing our present communities and future generations at the center of adaptation. In developing stormwater capture projects, the SCWP considers cities and communities that would most benefit from new amenities, including new open spaces like parks, activity areas, and trails.

2. Community Questions/Feedback

- Pollution and Street Sweeping. Discussion about trash and contribution to water pollution particularly during rain. Can SCWP fund cleaning projects?
- Rain and Pollution. Does SCWP fund 'Information Campaigns'? Important to clean polluted water but equally important to prevent water pollution by teaching resident best practices.
- Park Space. Concern that there is not enough effort by SCWP in creating or expanding green space, new parks.








